

Job Title: School Nursing Specialist Supervisor: Principal & Supervisor of Health Services

Position Code: 2E12, BE12 Pay Grade: 38

Job Classification: Exempt Contract Length: 195 Days

Job Summary

Position is responsible for performing specialized professional nursing care, providing health care services to students and staff, and improve attendance by reducing time lost due to medical problems. Primary assignment in setting consisting of medically fragile preschool students. Position assists with developing division wide standardized procedures; acts in a lead role to school nurses regarding special needs students (grades PK-12); and develops/conducts in-service training to school nurses regarding specialized techniques and procedures. Position organizes the health clinic at the assigned school; performs and interprets health screenings and medical examinations; recommends placement; assesses student health needs; performs intensive treatment services involving complex medical equipment on a regular basis; administers emergency care / first aid treatment; provides health counseling; and conducts related workshops. Provide a safe and healthy environment in order to maximize students' potential to learn.

Essential Duties

- 1. Organizes the health clinic at the assigned school and supervises the daily activities of assigned treatment nurses and clinic assistants.
- 2. Assists the Supervisor I (Health Services) with developing division wide standardized procedures for the health care of medically fragile/special needs students.
- 3. Acts in a lead role to school nurses throughout the division in assessing, evaluating, and developing/implementing health care plans for medically fragile/special needs students.
- 4. Develops and conducts in-service training for school nurses regarding specialized nursing techniques and procedures for medically fragile/special needs students.
- 5. Assists families and students in being accountable for their health status and improving attendance.
- 6. Prescreens and evaluates the health status of prospective students considered for admission into the division's several PEEP site locations by performing specialized health screenings, tests, and physical examinations; interprets/communicates findings; and provides recommendations for placement.
- 7. Provides direct nursing care to students and staff by administering medication, immunizations, first aid, emergency health care, and nursing care prescribed by a medical provider; and accompanies students to the hospital as necessary.
- 8. Acts as a member of the eligibility/child study teams and assists with formulating an appropriate health care plan for special needs and medically fragile students at the assigned school and other sites as indicated.
- 9. Maintains compliance with Individualized Education Plans (IEP)/Individualized Health Care Plans(IHP) and performs specialized nursing care, intensive treatment services, and difficult nursing procedures on a routine basis (catheterizations, suctioning, IV's, tracheotomy care, gastrostomy feedings, oxygen administration, etc.); and operates complex medical equipment.
- 10. Observes students on a regular basis to monitor illness and provide early detection of communicable diseases, child abuse, substance abuse, mental illness, depression, eating disorders, chronic illness, and physical defects; makes referrals to other professional staff members and community agencies as needed; and communicates findings to parents/guardians as appropriate.
- 11. Improve attendance by reducing time lost to illness and injuries.
- 12. Reports suspected cases of child abuse and neglect through the proper channels.
- 13. Serves as liaison between the school and family physicians to promote effective patient case management.
- 14. Recommends placement of medically fragile children after they exit the preschool program and provides nursing coordination for transitioning students to include developing transitional plans and providing follow-up services with the school nurse at the receiving school.
- 15. Enforces established infection control policies and procedures on the exclusion and readmission of students with infectious and contagious diseases.

- 16. Provides health counseling to individual students and parents/guardians regarding disease, emotional distress, pregnancy, and other health related issues as appropriate.
- 17. Serves as a resource to teachers and staff at the assigned school regarding the health needs of students and recommends modifications of the student's educational program/environment as necessary.
- 18. Participates in school based committees regarding the health and wellness of students to include crisis team and the substance abuse team.
- 19. Provides health educational materials and presents at workshops to students, staff, and parents/guardians on such topics as first aid, sound health/nutrition, eating disorders, Bloodborne pathogens, and proactive strategies for achieving and maintaining good health in children.
- 20. Ensures that sanitary standards of the school's health clinic are being met and maintains OSHA standards regarding Bloodborne pathogens and other potentially infectious body materials.
- 21. Assists school personnel with inspecting the assigned school for health/medical hazards; and recommends appropriate corrective action.
- 22. Maintains proper documentation and health records on all students within the assigned school, prepares/submits reports as required, and utilize the nursing components of the ESIS computer system.
- 23. Complies with laws, regulations, protocols, and School Board policies/procedures as they apply to school health services.
- 24. Requisitions needed supplies and equipment for the health clinic at the assigned school.
- 25. Models nondiscriminatory practices in all activities.

Other Duties

- 1. Maintains professional competence and keeps abreast of new developments in the health field.
- 2. Performs any other related duties as assigned by the School Principal & Supervisor of Health Services or appropriate administrator.

Job Specifications

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill and/or ability required. Reasonable accommodation may be made to enable individuals with disabilities, who are otherwise qualified, to perform the essential functions.

Minimum Qualifications (Knowledge, Skills and/or Abilities Required)

Must have graduated from an accredited school of professional nursing with some work experience as a Registered Nurse. Bachelor's degree in nursing preferred. Must be licensed, or eligible for licensure as a RN by the Virginia Board of Nursing. Must possess current CPR certification. Must have knowledge of professional nursing principles, practices, and techniques within a public school environment to include knowledge of medically fragile student health needs, human anatomy, physiology, child growth/development, basic pharmacology, medical terminology, and infection control measures. Must possess the ability to organize a clinic and supervise staff. Must possess the ability to serve in a lead role and conduct in-service training to school nurses. Must possess the ability to manage the health of medically fragile students and exercise judgment in the application of nursing care. Must possess skills in standard nursing procedures (catheterizations, suctioning, IV's, tracheotomy care, gastrostomy feedings, oxygen administration, etc.) and the ability to perform/interpret health screenings and physical examinations. Must possess the ability to maintain comprehensive health records, prepare clear/concise medical reports and use appropriate computer systems. Must possess excellent interpersonal and communication skills. Must possess the ability to establish and maintain effective working relationships with students, staff, parents/guardians, and outside agencies.

Working Conditions & Physical Requirements

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodation may be made to enable individuals with disabilities to perform essential functions. Duties are performed in a school clinical and classroom environment. While performing the duties of this job, the employee is frequently required to walk; use hands to finger, handle,

or feel; reach with hands and arms; talk or hear; smell. The employee must occasionally lift, push, pull, carry, and/or move patients and equipment weighing up to 100 pounds. Specific vision abilities required include close vision, depth perception, and ability to adjust focus for observing patient conditions and administering appropriate treatment. The job risks exposure to disease/pathogens; blood and bodily fluids; medications; and toxic or caustic chemicals.

Work Environment

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions. Duties are normally performed in a school/classroom environment. The noise level in the work environment is usually moderate.
