

Job Title: Secretary II, Operations

Job Summary

Position is responsible for providing customer contact and clerical support, and maintains billing information for department field trips.

Essential Duties

1. Serves as direct clerical support for the Operations Supervisor II.

- 2. Inputs completed field trip information into department Field Trip Management System for billing purposes.
- 3. Monitors the radio net control station by receiving and relaying information to and from drivers.
- 4. Serves as central point of contact for school bus drivers and school bus assistants to address and direct general concerns and questions.
- 5. Prepares statistical tables; correspondences, meeting notes, reports, bulletins, charts, questionnaires, requisitions, and other items as needed or requested.
- 6. Compiles information from various sources for records and reports.
- 7. Maintains a regular filing system and processes incoming and outgoing correspondence as instructed.
- 8. Handles incoming telephone calls and refers to other staff members when appropriate.
- 9. Inputs all complaints, concerns, and issues into the Issue Trak system.
- 10. Communicates with schools to assist with student bus concerns and other Transportation information requests.
- 11. Distributes all inter-departmental and postal correspondence to the appropriate person.
- 12. Inputs and files all Exception to School Board Policy forms for bus stop changes.
- 13. Creates and updates various forms used by Transportation.
- 14. Assist in the dispatch office as needed.
- 15. Assist with quarterly department billing.
- 16. Must be available to work a variety of shifts.
- 17. Maintains a high level of confidentiality.
- 18. Models nondiscriminatory practices in all activities.

Other Duties

1. Performs other duties as assigned by appropriate supervisor.

Must possess excellent verbal and written communication skills and have ability to establish and maintain effective working relationships with employees and the public. Ability to maintain confidentiality and demonstrate good judgment, tact and courtesy in difficult situations and with communications to the public.

Ability to organize and maintain clerical records and to prioritize workload. Must possess strong organizational skills.

Working Conditions & Physical Requirements
