#### **Points**

A minimum of 180 recertification points is required for renewal. To view your current point total in PLMS/Frontline please follow the steps below:

- Go to My Info > My License Summary(current)
  - o RenewalPoints column for total points qualifying for renewal
  - o EarnedPoints column for all points earned in current validity period
  - o MaxPoints column for maximum points allowed for each Option
- You must now complete a Relicensure Report or College Credit Request Form in PLMS/Frontline to be approved for points:
- Scan Documents/Certificates into your File Library in PLMS/Frontline
  - o Go to My Info > My File Library to Add Files (Certificates/Official Transcripts) as documentation
- Submit a Relicensure Report Form or College Credit Request Form
  - o Go to Forms > FILL-IN-FORMS Track your PLMS/Frontline requests:
- Go to My Info > View in Progress and click on the course/activity link to determine if Prior
  - Approval has been completed
- After Prior Approval you must select "Mark Complete" and upload documentation to the request form for Final Approval
- Continue to monitor your "View in Progress" activities to determine processing stages PLMS is new for NNPS and we are working diligently with Frontline to resolve issues.

## 10-Year Renewable Licenses

Effective July 1, 2018, the VDOE is issuing 10-year renewable licenses. The statute does state that individuals renewing ten-year licenses will be required to complete up to 360 professional development points for renewal.

## SUBMITTING A RENEWAL PACKET

To submit a renewal packet

- Ensure you have met all the requirements listed above
- Complete Page 1 of Application for License Renewal found on the licensure website
- Ensure all your certificates of completion have been uploaded in Frontline and you have met the minimum number of points required.
- NO FEE. NNPS is currently paying your \$50 renewal fee
